COVENANT HOUSE PROVIDES EMERGENCY SHELTER AND CRISIS CARE TO RUNAWAY, HOMELESS AND TRAFFICKED YOUTH BETWEEN THE AGES OF 18-21. WITH 45 BEDS IN NEWARK AND 27 IN ATLANTIC CITY, THE FOCUS IS ON STABILIZING THE YOUNG PERSON'S CRISIS BY WELCOMING THEM TO A SAFE ENVIRONMENT AND PROVING FOOD, CLOTHING AND A WARM BED. THIS YEAR, OUR EMERGENCY SHELTERS SERVED 518 HOMELESS YOUNG PEOPLE WHO HAD NOWHERE ELSE TO TURN.
